Puppy Reservation & Purchase Agreement

At Regal Crest Standard Poodles, we are committed to raising exceptional Standard Poodles with intention, integrity, and care. This Agreement is designed to ensure clarity, transparency, and a supportive experience for both our families and the puppies entrusted to us.

This Puppy Reservation & Purchase Agreement (“Agreement”) is entered into between Regal Crest Standard Poodles (“Breeder,” “we,” “us”) and the undersigned Purchaser (“Client,” “you”).

1. Breeding Program Philosophy

Regal Crest Standard Poodles is a boutique breeding program devoted to producing Standard Poodles in black, white, and brown with sound structure, balanced movement, and emotionally intelligent temperaments.

Our puppies are raised in a home-centered environment and receive daily care, gentle handling, and early foundation practices to support confidence, adaptability, and a smooth transition into family life.

2. Reservation Deposit, Waiting List Priority & Placement Order

A \$500 non-refundable reservation deposit is required to secure priority placement on the Regal Crest waiting list.

Reservation deposits are applied in the order received and establish priority placement, which determines the order in which families are offered puppy selections once puppies are developmentally ready.

Important considerations:

- The reservation deposit secures priority placement, not a specific puppy.
- Preferences for color, gender, or individual puppies may be shared but are not guaranteed.
- Puppy selection is based on reservation order, temperament, developmental readiness, and overall fit.

Regal Crest Standard Poodles reserves the right to:

- a. Adjust placement timing based on puppy development
- b. Delay, skip, or decline an offer if a particular match is not in the puppy's best interest
- c. Retain any puppy for breeding or program evaluation
- d. Deposits may be transferred once to a future litter within the Client's selected timeframe, subject to availability. After three declined selection opportunities, the deposit will be forfeited.
- e. This process ensures fairness, thoughtful placement, and the long-term well-being of every puppy.

3. Puppy Selection & Placement Philosophy

Puppy selection occurs when puppies are old enough for accurate temperament evaluation. Our goal is not speed, but suitability.

Final placement decisions are made at the sole discretion of Regal Crest Standard Poodles to protect the integrity of our program and the welfare of our puppies.

4. Purchase Price & Final Payment

The total purchase price of the puppy will be communicated prior to selection.

Payment Terms

Final payment is due no later than two (2) weeks prior to the puppy's scheduled pickup or transport date

Personal checks are not accepted

Accepted payment methods include:

- Zelle
- ACH / Bank Transfer
- PayPal

If PayPal is used, the Client agrees to cover the applicable processing fee (currently 3.5%), which must be added to the total payment amount.

Failure to submit final payment by the required deadline may result in forfeiture of the reservation deposit at the Breeder's discretion.

5. Health & Wellness Guarantees

Each puppy is examined by a licensed veterinarian prior to placement and is up to date on age-appropriate vaccinations and deworming.

5.1 Florida Veterinary Examination & Purchaser Rights

In accordance with Florida law, the Client is encouraged to have the puppy examined by a licensed veterinarian of their choosing within seventy-two (72) hours of receiving the puppy.

If the veterinarian determines that the puppy is unfit for purchase due to illness or congenital defect that existed at the time of sale:

The Breeder must be notified in writing within two (2) business days

Written documentation from a licensed veterinarian is required

Remedies will be provided in accordance with Florida Statutes §828.29 and may include a replacement puppy or reimbursement, at the Breeder's discretion.

5.2 Initial Health Guarantee (7 Days)

The puppy is guaranteed to be in good health at the time of transfer. This guarantee applies to the original purchaser for seven (7) days following delivery or pickup.

After this period, the Breeder assumes no responsibility for conditions arising from environmental changes, stress, diet, injury, or veterinary care administered after transfer.

5.3 Genetic Health Guarantee (Two Years)

The puppy is guaranteed to the original purchaser against life-altering hereditary or genetic conditions for two (2) years from birth.

If such a condition is diagnosed:

- Written documentation from a licensed veterinarian is required
- The Breeder must be notified promptly
- At the Breeder's discretion, a replacement puppy of equal value may be provided when available.

5.4 Excluded Conditions

This guarantee does not cover common or non-life-altering conditions, including but not limited to:

- Parasites (including giardia or coccidia)
- Umbilical hernias
- Minor or undesirable bite alignment
- Allergies
- Stress-related illness
- Conditions influenced by environment, nutrition, injury, travel, or veterinary care after transfer

5.5 Limited Cost Coverage (3-Day Exception)

Within the first three (3) days, the Breeder will cover up to \$150 toward veterinary correction of:

- Umbilical hernias
- Undesirable bites

- This coverage requires written documentation from a licensed veterinarian and notification within the applicable warranty period.

6. Companion Placement & Lifetime Commitment

Unless otherwise agreed to in writing, all puppies are sold as companion animals and not as breeding or show guarantees.

The Client agrees to:

Provide lifelong care, proper nutrition, training, and veterinary attention

Maintain the dog primarily as an indoor companion

Never surrender the dog to a shelter or rescue

If rehoming becomes necessary at any point, Regal Crest Standard Poodles must be contacted first.

7. Delivery, Transport & Transfer of Responsibility

Puppies are released to their new families at approximately eight (8) weeks of age, unless otherwise agreed in writing.

The Client is responsible for coordinating pickup or transport arrangements and all associated fees.

If a third-party transporter is used, all agreements are between the Client and the transporter directly.

Regal Crest Standard Poodles is not responsible for delays, injuries, illnesses, losses, or damages that may occur once the puppy leaves the Breeder's care. Any transporter recommendations are provided as a courtesy and do not constitute endorsement or liability.

Responsibility for the puppy transfers fully to the Client at the time the puppy is released to the Client or designated transporter.

8. No Additional Guarantees

No guarantees are made regarding adult size, coat presentation, show or breeding potential, or exact temperament outcomes beyond early foundation and care.

9. Governing Law & Venue

This Agreement shall be governed by and interpreted in accordance with the laws of the State of Florida. Any disputes arising from this Agreement shall be resolved exclusively within the State of Florida.

10. Agreement Acknowledgment

By submitting a reservation deposit and signing this Agreement, the Client confirms understanding and acceptance of all terms outlined herein. This Agreement represents the complete understanding between both parties and supersedes any prior communications.
